Hope Elementary School District engaged in consultation with our community in a variety of ways in order to assure that feedback loops provided accurate information so that all participants would be empowered to make informed decisions. The planning process for the multiple state and federal emergency relief funds received by the district was incorporated with established processes for planning the district budget and the district Local Control Accountability Plan. Examples of methods are: surveys sent to staff and parents, a social media live stream Q and A session with staff and parents, formal meetings with educational partners (school board, SSC/ELAC, classified and certificated staff), conversations with parents before school and after school as they were dropping off and picking up their children, as well as board meetings each month. Greater detail for involvement can be found on our LCAP. It was the superintendent/principal's responsibility to coordinate involvement and provide findings. Information, consultation, and decision-making processes specific to ESSER III began upon district notification of funding in the spring.

A description of how the development of the plan was influenced by community input.

Through the Q and A session with parents, it was brought up that we needed additional tutoring time and someone on campus who could support the social and emotional needs students were displaying due to being at home for months without any interaction with their peers. In staff and parent surveys received by the district, both staff and parents identified that Hope School needed a reading teacher to catch up kids who had fallen behind during the school closure. After analyzing data with the school board, the board (with the input from many educational partners) felt that the addition of a Reading Specialist and paying teachers and aides after school to tutor would yield increased student achievement.

Specific aspects of the ESSER III Plan developed by community input are:

- addition of a reading teacher (parents, including parents of English Learners, teachers, administration)
- increased tutoring time (students, parents, including parents of English Learners, teachers, administration)
- increase social and emotional supports for students (teachers, administration)

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
